

WAS THE WOOL PULLED OVER YOUR EYES (AND EARS)?

AN OPEN CHALLENGE TO SANHA

We are a group of people who are involved with The Jamiat and are seriously bothered by the cover ups carrying on for some time. Because we fear being victimized, we prefer to remain anonymous. We are extremely worried about the present controversy concerning Early Bird Chickens as it affects every Muslim house.

This much we are aware of that the interviews conducted by Moulana Sulaiman are not as spontaneous and innocent as it may appear to the public. Strategies and questions are prepared beforehand. Consultations take place amongst various role-players. Tactics are discussed and an approach is decided upon which ensures that SANHA, Radio Islam and The Jamiatul-Ulama's reputations remain intact, even if it is at the cost of Truth.

We have seen it time and again: The SANHA logo on the Pork packet, SANHA ACCREDITING ISRAIL'S PRODUCTS, Radio Islam justifying its involvement with the Amercian Embassy -the list goes on and on...

There are person(s) who are willing to take an oath in the Masjid in front of SANHA Ulama and the public that they were informed by the Moulana(s) that the 48 chickens per minute had a role in the resignations.

Let the Truth prevail. Let's see if the "Referee" is honest and sincere IN HIS CLAIM OF SERVING THE COMMUNITY or if he is a puppet of SANHA.

Let the two Moulana's individually take oaths upon the Sacred Qur'aan and save the stomachs of the Ummah from the possible consumption of Haraam spring rolls and Samoosas!

The ball is in SANHA'S court!

Many members of the public are still flabbergasted at SANHA's Karaamat of explaining how ONE PERSON can slaughter 48 chickens in 60 seconds with Tasmiyah. (1.25 seconds per chicken!)
