Molvi AS Desai,

*Assalâmu 'alaykum*

According to the jaundiced and prejudicial views expressed in your tabloid, the Majlis, you have repeated *ad nauseam* which you cannot deny, that you hold and propagate the following views on the status of all Halaal processed poultry in South Africa:-

**1. "All chickens slaughtered in South Africa including Earlybird and Rainbow are Haram and that they are in fact carrion".**

To quote from your writings you state-

***"The MJC has no perception of Shar'i supervision and no concept of halaal and Haram. In fact, the very senior Sheikhs of the MJC have always discarded the importance of reciting Tasmiyah when slaughtering. By them, it is an optional issue of insignificance. In the past we have thoroughly proven that they do not understand even the masaa-il of the shafi'i Math-hab on the issue of Thabh."***

***"Muslims are urged to abstain from ALL processed chickens- Early Bird Rainbow and every other kind of chickens certified and approved by SANHA or any other so-called 'halaal authority'. These 'halaal authorities' have certified and fed Maitah (diseased carrion) to the Muslim community for years."***

***"The first step in this direction in our situation is to abstain from SANHA, MJC, and NIHT certified Haram maitah (carrion)"***

2. You declared that, “SANHA as a certifying body with its staff and ULAMA are ‘murtads’ (apostates), i.e. out of the fold of Islam”.

Therefore, slaughter by “murtads” would render the products Haraam.

3. You wrote that *“the word of a non-muslim manufacturer is more reliable and acceptable than the words and assurances of a body such as SANHA”* and that *“the certification SANHA issues has no validity”*.

Does that mean all that is certified is infact Haraam?

4. “SANHA indulges in riba (interest) money”.  
*“The funds it sucks from traders on the basis of these Haraam scraps of papers and for its lousy superficial ‘inspections’, is Riba according to the Shariah.”*

SANHA according to you indulges in riba and the products they certify are Haraam.

From the above assertions, it is patently clear to anyone with the slightest modicum of common sense to understand that according to you and your views (not facts), all Halaal certified products are Haraam.

Furthermore, your tabloids view on poultry from commercial abattoirs being Haraam has been consistent through the years. Why then do you and your minions create a red herring and persist with your vendetta and propaganda of diversionary and irrelevant issues such as line speed, number of birds slaughtered per minute, inspections, supervision, packaging, contamination etc? We respectfully question how will the *‘unfettered inspections’* that you and your agents, the *‘independent group of Jamiat Gauteng molvis’* want to conduct, change your well known and documented view of Haraam.
